






Whoever destroys, damages or renders unfit for use, or conceals, or removes a document to which he has no exclusive right of disposition shall be subject to a fine, the penalty of restriction of liberty or the penalty of deprivation of liberty for up to 2 years.

#### **Gamifying crime**

# Article 258 of Polish Penal Code — "Participation in an organized criminal group or association"

- § 1. Whoever participates in an organized group or association having for its purpose the commission of offenses shall be subject to the penalty of deprivation of liberty for up to 3 years.
- § 2. If the group or association specified in § 1 has the characteristics of an armed organization, the perpetrator shall be subject to the penalty of deprivation of liberty for a term of between 3 months and 5 years.
- § 3. Whoever sets up the group or association specified in § 1 or 2 or leads such a group or association shall be subject to the penalty of deprivation of liberty for a term of between 6 months and 8 years.



§1. Anyone who, through the persistent harassment of another person or another person's next of kin, creates a justified sense of danger or significantly violates the person's privacy, is subject to imprisonment for up to three years.

## Article 189 – "Deprivation of liberty"

- § 1. Whoever deprives a human being of their liberty shall be subject to the penalty of the deprivation of liberty for a term of between 3 months and 5 years.
- § 2. If the deprivation of liberty exceeded longer than seven days, or was coupled with special torment, the perpetrator shall be subject to the penalty of the deprivation of liberty for a term of between 1 and 10 years.

Time and time again I notice hordes of apparently confused or bored, low-life morons, who either through their ignorance or stupidity were sold on the idea that acting like a mob and engaging in criminal behaviors is somehow "playing games".

Oftentimes I'm also on the "receiving end" of such.

So, if we're clear on how these are actually called, what penalties for such apply, and – if you happen to be part of such animal mob – who you are to me, let's proceed to one of the most recent examples.


#### **Gamifying crime**

On May 21st 2019, I sent a package via International Priority Mail, addressed to the European Court of Human Rights (ECHR).

Package contained complete documentation related to complaint being filed, 42 documents in total:

- Fully completed Application Form,
- Annex to Application Form, section I. List of accompanying documents,
- Annex to Application form, section E. Statement of the Facts,
- All 39 documents listed in section I. List of accompanying documents

Prior to packaging and sending it, I took photographs of all documents included – each photograph contains original EXIF metadata.

The same day, May 21st 2019, I sent to the ECHR an email with information about application being filed, and attached Application Form itself along with both Annexes—those documents clearly mention which additional documents I'm sending via post.




According to the confirmation of delivery generated from the Polish and French post systems, the shipment was delivered on June 3rd, 2019.



On June 28th, 2019, I found in my mailbox a letter from the ECHR, sent as an ordinary, unregistered letter, containing a document dated June 20th, 2019, in which the alleged representative of the ECHR informs me that, on the basis of Article 47, they refuse to take on the complaint, because documents are missing...

Considering that the priority parcel was delivered on June 3rd, 2019, and the ECHR receives thousands of applications, it is an incredibly short time to read all of the documents I enclosed, then issue a decision and have it sent out.


Most importantly, all those supposedly missing documents mentioned in the ECHR letter I received:

- were included in the parcel I sent,
- are clearly listed in Section I. "List of accompanying documents",
- and there are no other documents concerning these issues, so no other documents could possibly be provided.

Documents that the ECHR representative allegedly could not find are clearly listed in Application Form, section I. List of accompanying documents, as well as on the Annex to Application Form, i.e.:

- Item #10: Decision refusing to initiate an investigation, dated April 14th 2014
- Item #34: Complaint for infringement of a party's right to hear the case in preparatory criminal proceedings without undue delay, filed on June 5th 2018
- Item #36: Court's decision regarding the complaint for infringement of a party's right to hear the case in preparatory criminal proceedings without undue delay, along with confirmation of delivery of that decision on November 22nd, 2018

So just to emphasize if this is not clear yet:

- package with all relevant documentation sent to the ECHR (European Court of Human Rights) was tampered with,
- documents were removed from that package,
- then decision issued claiming that because those same documents are missing complaint is inadmissible

The complaint I filed with the ECHR concerns jus cogens crimes—performing medical procedures / scientific experimentation without consent, and the subsequent 5+ year long cover-up of this crime—result of which is permanent bodily injury, and invokes articles 2 ("Right to life"), 3 ("Prohibition of torture and inhuman or degrading treatment"), and 6 ("Right to fair trial") of the European Convention on Human Rights.

Since no other documents concerning these specific matters which ECHR raised in their letter dated June 20th 2019 exist, except those I listed in section I. "List of accompanying documents" and included in the package, it is evident that the package, addressed strictly to the ECHR, was tampered with and documentation contained in it deliberately removed, rendering my complaint inadmissible.

Aside from the fact that hiding information / destroying documentation reaffirms the allegations contained in that complaint, it is also apparent that the perpetrators want to continue to act with impunity.

Tampering with documentation, destroying documentation, and through such means preventing me from exercising my rights in seeking redress and compensation for damages I suffered, are serious crimes on their own.

This is not the first time documentation concerning these crimes, filed by me in courts and prosecution cases, is being removed or destroyed.
