Good afternoon, Mr. Siemaszko,

Thank you for your message. I assure you we do our best to work as fast as possible. As we are not the provider of the health-care, the delay is created in the contact with the Clinic.

I asked for any restrictions before the examination is done. The doctor confirmed me that for the laboratory tests there are no limitations and you should follow your daily routine. The only recommendation is for the spermogram, for better results you avoid having sex for 5 days.

The exact time for the tests you mention will be specified by the doctor at the Urology clinic. You have scheduled meeting on the first day morning. Within 60 minutes the doctor will discuss with you the problems you're having and review the treatment you already had - this is the vital part of the

whole procedure of setting a right diagnose. Then he will decide if any extra tests are required or he will do the ones from the Urology package. The only two test which needed to be booked for the availability is the MRI and spermogram - those dates I mentioned below.

I hope you understand why I can't write you down exact time of each test. But we still work within the frame of 48 hours for setting the diagnose.

Regarding the cost of the Urology package, we need to have the 100 % deposit on our account no later than the day before the care is provided. Otherwise the Clinic is not able to provide you the services.

Dear Mr. Geier,

It's been a week since I deposited 250 EUR and was promised to receive information regarding dates **as soon as possible**. We spoke on Friday and I was told I would receive these **by Monday morning**. I have not received **neither an email at that time nor a phone call**, only after my follow up phone call Monday afternoon I received your reply.

Mr. Geier, these are **very serious matters** - my expectations and intent behind these tests was explained in detail over the past few emails we exchanged. The result must be a comprehensive diagnosis and documentation in English in order to follow up with both therapy recommendation as well as forensic expertise.

Based on my impressions so far, I cannot pay up front the full amount without knowing what I can expect next. 250 EUR was already paid up front, for the remainder (1000 EUR) I can offer alternative solution: paid up front each day before tests; depending on how this will be handled further, each following day paid up front up to the full amount.

Dear Mr. Siemaszko,

Currently we have four facilities where the examination and following treatment is possible. Two of them are Faculty teaching hospitals (Charles University Prague), one is a private hospital and one is a private urology center. In some cases the doctors are the same because they give the lectures at the faculty hospital. But all of them can recommend the treatment only after examining you personally. After consulting your documentation, the optimal start would be run the test I described earlier. The medical documentation needs to be checked for the possible progress of the disease.

The facilities we found for you has the highest certifications and the doctors are top capacities in the field of urology with many years of clinical practice.

I would be happy to ask for the specialized opinion on the medical records you sent us. The price will be € 225 and € 15 x 3 for the translation. But you have to understand that without a physical check-up it will be based on the inactual data.

If you decide for the examination package you will receive a comprehensive medical report, wrote by the chief doctor of the respective clinic/hospital. We can of course ask for the forensic expert to confirm the validity of the document .

In January 2014, over the course of 1-2 days, my health condition (urogenital area) deteriorated rapidly, form & function of this part of my body changed significantly. This diagnosis must provide me with sufficient data to answer questions such as whether candidiasis treatment I was undergoing at that time by itself could cause such change in physical form & function, including large amount of urine retention - which is very doubtful, considering the scars on my body, the very visible changes to genital area, etc.

After familiarizing yourself with this documentation, kindly please let me know:

- what tests you'd recommend to start with, unless these remain the same as you previously mentioned
- whether the doctor diagnosing me is (or whether you have other experts on site) experienced in side effects of Candidiasis treatment with pharmaceuticals mentioned in the documents
- whether the doctor diagnosing me is (or whether you have other experts on site) experienced in examination which will later be used to formulate forensic expertise (this condition might be connected to assault I experienced in January 2014) - forensic will be done by specialized institution, however, if you have experience in formulating results in an unambiguous way to be used in such, it would be very helpful

Regarding your mention of oncology department - I did not suffer from nor underwent any cancer related treatments; I did mention this change (in how urogenital looks & functions) **happened suddenly** (over the course of 1-2 days); cancers, as far as I know, develop over much longer periods of time and various symptoms can be picked up and acted upon consciously.

I will be in touch this coming week with documents I mentioned earlier.
