

21st century genocide - systematic suppression and grave violations of human rights

Mark Podlecki: Good morning, I am speaking with Michael Siemaszko. If you do not remember who is Michael, I advise you to watch the old materials that we recorded in 2009 with Peter Bein from Canada. Michael, we met on the occasion of the of anti-vaccine campaigning in 2009, you were the one who run the group on Facebook, you were the person, who was attempting to register association "Civilization of Life".

Michael Siemaszko: We worked together in 2009 on the occasion of campaign whose aim was to stop forced vaccinations. I run i.e. a group on Facebook at that time, as well as an internet website, "Świńska Sprawa" ("Swine Case").

Mark: You were i.e. the organizer of this big meeting at the Grotoska Theatre.

Michael: Yes, we co-organized a meeting with Mrs. Jane Burgermeister at the Grotoska Theatre. We also co-organized a meeting with Peter Bein in Krakow. I helped Mr. Peter, Mr. Mark. We conducted leaflet, poster, internet campaigns. I also wanted to register an association, in order to move these matters forward and so that this is not a one-time act, but to be able to act in diverse topics, because it was not only about vaccinations and it still isn't, but various other methods of systematic depopulation of which people are unaware. My association, "Civilization of Life", was sabotaged, it was not even registered, because I had supposititious people. But all of this started a little earlier, after the death of my daughter in year 2007.

Mark: Yes, I did not know whether you want to talk about this. I knew about this death. I did not know these details that I know now, which to me are really shocking. Ladies and gentlemen, what we are saying is only a part of what we can release. A lot of things we cannot release, for a number of reasons - you would simply not believe in these things. Daughter of Michael and Mary, in the eighth month of pregnancy, was murdered.

Michael: Because it was my first child, through all of the first months of pregnancy we would go for USG - systematic examination was being done, once every two weeks, at least once a month. In the sixth month of pregnancy, some issues related to her heart came out. We deliberated traveled to Warsaw to a specialist. It has been verified and he was not particularly concerned about the situation. Tola's mother was taken to maternity hospital, where she spent a month's time. Myself, witnessing her birth, I also took part in all of this from the very beginning. Immediately after delivery, Tola was taken to Children's Hospital in Prokocim and died after 2 weeks. She had multiple surgeries, i.e. a surgery of the intestine, heart surgery. Unfortunately, only after 3 years, after I split up with Ms. Maria, various details regarding the genesis of this began to come out. It turned out that the child has been deliberately killed during pregnancy through administration of pharmacological agents. This was not an abortion, because abortion is permitted only up to the 3 month of pregnancy.

Mark: (Children's Hospital in Prokocim) is an American hospital, from which many children with autism came out. I know personally children with autism.

Michael: I do not know whether the hospital took part in any of this. I do not know, I can not confirm. But this took place in the 6th or 7th month of pregnancy when pharmacological agents, which caused the defects with which the child was born, where

given to her or she took them herself. However, the hospital itself - I can not say a lot of good things about this hospital, neither. In any case, all of the documents related to my child were taken at the time when I split with Mrs. Maria. All that remained was the death certificate and the birth certificate of my child. What's more, it turned out that my closest relatives were also involved, i.e. with what happened with Tola, as well as in the theft of several hundred thousand PLN.

Mark: Well, I remember you very wealthy. You had very cool bikes, you were coming (to our meetings) with latest model of laptop, Macintosh if I'm not mistaken. You did not have financial problems. You looked better. And now, I must admit to you honestly, Michael came to me because he had nothing to eat.

Michael: I came to Mr. Mark, because after 3 years from 2010, when I was doing what I could systematically being banned and, in fact, persecuted. Perhaps let's go back to year 2010. I was told by at least 2-3 people, with whom I wanted to sort out all of these issues sensibly after splitting with Mrs. Maria, that because of the anti-vaccine campaign, that I should stop dealing with these issues, otherwise I will have problems. I am not going to, was not going to and will not stop dealing with these issues, for as long as these issues exist and until such things are taking place. So, for my part, nothing will change. For as long as I live, I will not stop dealing with matters that affect me and potentially the children, which I would like to have.

Mark: Exactly, wasn't it your child, killed, wasn't one of the reasons why you started the anti-vaccine campaign?

Michael: Of course it was, but the anti-vaccine campaign was just one of the issues. I wanted to continue this activity under the aegis of the association, which was sabotaged. Because there are a lot of these topics. I.e. it's about GMO food after all, about geoengineering, it's about forced vaccinations.

Mark: I have to admit that Michael is very familiar with these topics. These will be next talks.

Mark: For now, let's focus on what's happening with you Michael. In your group on Facebook, there were about one thousand people, if not more, right?

Michael: In the group, yes, there were more than a thousand people, while the site was visited by tens of thousands of people. However, that what has taken place since that time, perhaps I'll mention: On at least 5 or 6 occasions, when I was renting an apartment or room in various places in Poland at least several times there was an entry to the place where I lived during my absence or while I was sleeping.

Mark: ... for which you have evidence?

Michael: I have pictures of some of these situations. Besides, I know what the effect was on my body. I have been vaccinated at least twice, without my permission, of course. And in all of this, Mark, the most important thing is to talk about this. I am doing what I can do, but the idea is to talk about this because the people who are doing these things, rely on the fact that this is not visible, that they can do anything while you have no means, in any way, to strike back because, well, quite simply for the last 3 or 4 years I could not afford to hire an attorney or to draw up the appropriate legal expertises to begin enforcing what is mine. So most important is to talk about this and, in the meantime, of course, yes, I would like 'get back on my feet' financially. Despite the fact that I'm doing what I can, I had at least four or five supposititious projects - these are further losses in the tens of thousands of zlotys (PLN) where, in spite of performing my duties, communication with my superior, I

was suddenly being dismissed from the project. Well, I don't know, these people think that when I start working at some corporation, suddenly these topics, like compulsory vaccinations, geoengineering, or genetically modified food, or many other topics I will say that this is in any way acceptable, or what has taken place before is acceptable. It is not and will not be acceptable. So, when I cooperate with someone, performing my duties my obligations towards that person are only such as per agreement. I have no obligation in any way, ideologically or in any other way, to subordinate myself to that person. So, that's how this looks. But, most importantly, is to talk about this, right?

Mark: I see that you have prepared some materials here on your laptop, which must be powered from the network, because the battery is not working.

Michael: Well, the laptop is in such condition as it is. However, money is acquired, right? I was on my own from the nineteenth year of my life, so just for these past three years it is the first such period when - and only by the fact that this is a deliberate action - this is stalking, this is gang stalking, this is systematic.

Mark: I'll interrupt you for a moment, I apologize. For those of you who do not believe that something like this could happen, I will give an example of Jane Burgermeister. (This) woman is hiding at the moment. She moved to Berlin. We do not know in which country she is at this point. I asked a clairvoyant. She said that "somewhere in Europe". Jane Burgermeister was attacked, and a lot of times, through means of which Michael is speaking of. This is a very strong person. Michael is also a very strong person. I suspect that's why these people are alive. Michael, are you comparing your situation with what is going on with Jane Burgermeister, about whom it started to be quiet? This is a dangerous situation.

Michael: Mark, maybe mention that Jane was also being dismissed from work suddenly. Her father was killed. She had various problems. Her closest friends suddenly turned away from her. Simply put, so to speak, deliberate actions aimed at silencing, muting and discrediting given person.

Mark: And discredit her by the way, because it was also being said that she does not exist.

Michael: Exactly. And what's more, I was repeatedly threatened, like "We will erase you", "You are being hunted" as well as other punishable threats. So called "Hunger games", which has been confirmed repeatedly.

Mark: I will interrupt again, Michael, you speak English very well. You switch to English, but why. Because this whole thing, it is not only about Poland, because the forces with which we play are these illuminati forces. These are international usurious connections.

Michael: Of course.

Mark: And that's why Michael is such a dangerous person, because you know English very well.

Michael: Well, I do know English. Just for the past 20 years I'm learning and using English language. It is also i.e. one of the things that I can still offer - i.e. translations - but we'll talk about this later. Besides, information with links will be attached to this (video) material, where my ads are posted. I'm not asking for money by no means, I'm just asking for (work) orders and that is all, because I'm not disabled so that I could not work. The point is that so far I have not contacted Mark, because I did not know that on so many fronts this is organized so perfidiously where, despite my best efforts, best intentions, I am constantly being flunked and blocked. So, at the end of August (year 2013), a few weeks ago I contacted Mark, because I simply did not know what to do anymore. When another project

it turned out that suddenly I do not get an order, where I offered bids. I did what I could. Again, for example, I cannot get through (on the phone). My emails are not arriving.

Mark: Not only are not arriving, but are being exploited, because I know that someone is impersonating you, to give you problems, put simply.

Michael: That also, that as well. So, perhaps we'll continue. "Hunger games" or food games. The idea is that, since these actions were systematic - stalking, blocking earning opportunities, sudden dismissals, robbing, many many others. Possibilities of a normal communication (being blocked). Games which are taking place for the last several years are intentional and systematic. The result of which many times, even very often, I had nothing to eat. I barely lived on bread with butter and water. And even with (obtaining) this sometimes there was a problem. It was summer now so I had episodes where, thanks to the fact that I found a field with blackberries, I could live on blackberries for two weeks.

Mark: Yes, because you're a vegetarian.

Michael: I'm a vegetarian, yes, but over the winter, autumn, well, it is hard to find such places, right? On the whole, these are frequent violations of human rights. I felt like a slave. I still feel like a slave. As if, to say the least, my life belonged to someone else. I do not know whether to the State - I'm talking about the government - or whoever else is involved in this. My life belongs to me. I have the right to decide about my life. I have the right to decide with whom and where I want to live. If I'm putting my effort into something, I want to see the results of this work and not that my work is constantly being hijacked by someone else. That my money is being stolen from me. That my health is being destroyed. Where I have no possibility, in any way, to "get back on my feet", to hire a lawyer or to draw up appropriate legal expertises, because all the time I'm financially, so to speak, in a hole. The whole time I'm in the so-called "survival mode". So, perhaps we should move on to the next point. Twice, I was arrested and it was a litmus test of sorts, a bit. It happened to me a few times that I was stealing food from the store, because I needed to eat. It wasn't summer and I realized that if such things are taking place, why should I have nothing to eat? So, a few times it happened that, indeed, I stole food from the store.

Mark: Ladies and gentlemen, IT specialist, perfectly familiar with English, who could earn 60,000 pounds (GBP) a year.

Michael: I earned 10,000 PLN in 2010 (per month), per invoice. Such invoices I was issuing. I receive proposals from England for 60,000 pounds (per year), but I can not afford, for instance, to go there.

Mark: Relocation?

Michael: The relocation I cannot afford.

Michael: I cannot afford to rent a flat or to pay for food.

Mark: Besides, you do not know where you'll end up also.

Michael: Besides, I do not know whether this will not be another supposititious project, because this already happened at least five or six times. I'm not sure who is inviting me, so without financial collateral, I will not possibly borrow that money.

Mark: I think that you are doing very well, that you are trying to protect yourself, because we know who we're dealing with.

Michael: I have to protect myself.

Mark: You've been vaccinated. Tell me about this, because this is something terrifying.

Michael: Yes, at least twice during sleep, there was a walk in into the place where I lived - renting a flat or a room - and I was vaccinated. This showed itself in such a way that for two - three weeks I was sweating, I had breathing problems. Later, I had cognitive problems. In vaccines, there are i.e. heavy metals.

Mark: They have a variety of ways. I wrote about how I was attacked by - I suspected - infrasonic waves. I found a crew that looked like a Mossad crew in my apartment. And, supposedly they were checking voltage, whether it is in accordance with a European standard - something that the power company laughed at, there was nothing like that. I believe you Michael - (they) attempted to eliminate me.

Michael: You know Mark, I believe you, you believe me, but these are things that I confirmed with at least 5 - 6 individual people. Since year 2010 I've been to meetings with many people, where I came with a list and I talked to these people and these people in turn were confirming me these things. These are not things which Mark or I myself have dreamed up. Mark is also in contact with other people with whom he talks and these people are confirming this, so this is not one - two persons, these are people who independently are confirming the same information. I was told already 3 or 4 years ago by some people with whom I am still in touch things that I had to arrive at myself for the last 3 years, because they were so unbelievable to me only by experience, through the extraction of material from the subconscious, only then it started to occur to me, because it concerned my closest relatives. So, perhaps more about the arrests. The first time, when I mentioned one of the places where I lived where my health was quite strongly impaired - that is, on the Kostrzewskiego street in Krakow. When I mentioned about Kostrzewskiego street, I was quickly released, although prior to that I was threatened with a night in custody. The second time however, when I mentioned someone else, where I had a supposititious project, in Brzozow, in the subcarpathian voivodeship, this person, all of a sudden, even though I was performing my duties, began to threaten me with being beat up and told me to get out of the office of course, I went to a Police station and reported a criminal offence. When I mentioned this, Policemen suddenly released me, giving me the lowest possible mandate.

Mark: Twenty zlotys (PLN).

Michael: Twenty zlotys, yes. Despite the fact that they also threatened me that I would be put into custody.

Michael: So, this says that it is probably not organized crime, but either organized crime cooperating with law enforcement authorities that has/had a part in this and we all know how the illuminati work, right - Police is really only following orders they are obliged to follow orders. Fortunately, not all cops are corrupt, some of them can think.

Mark: Most of them are not (corrupt).

Michael: Unfortunately, some have no idea at all about what they're doing and that they are carrying out orders of people who, despite the fact that they are in high positions, are criminals and psychopaths.

Mark: About what I have written many times.

Michael: About what Mark has written many times and what was confirmed by their actions over the last few years. So, that's how this looks more or less in a nutshell.

Michael: Mark, question (me).

Mark: Now perhaps let's move on to the key point - how one can help you?

Michael: As I'm saying, I'm not a disabled person. I simply need, as soon as possible, to collect adequate resources to, for example, detox myself from accumulated toxins, the result of the vaccinations.

Mark: You want to detox your body.

Michael: I want to detox my body.

Michael: I.e. because of what took place, I have diabetes. Immunizations cause type I diabetes. I have that because of what took place.

Mark: And you did not have (that).

Michael: By no means did I have (that) before. Because of intrusion into my body I have type I diabetes. Four months ago I was ordered (by doctor) more than 15 blood tests, unfortunately I could not afford to do these tests. And I also have i.e. candidiasis. And of course to get out of the "survival mode". I barely have enough for rent and food, so I simply need to have standing orders (for my services).

Mark: So you can survive.

Michael: So I can survive, yes.

Mark: I'll just interrupt Michael for a moment. A few days ago, I've was at clairvoyant's - more, at exorcist's. She does not even need to see a photo of a given person, in order to track down that person she needs a mental image. And she visualized Michael. And I asked this person, this exorcist, about this topic. She said clearly: Mr. Michael needs a clearing. I don't know what else is in him - whether he is chipped or something else - but this would be a confirmation of what you are talking about.

Michael: I.e., I'm clearing myself - we can proceed to that in a moment. I'm clearing by energetic body regularly, almost every day.

Mark: But you're not sure whether by any chance you were not chipped.

Michael: With regards to that, then absolutely. So, it's more in this direction. By no means do I have anything to do with Satanism or with such energies, quite the contrary. On the other hand, how you can help me - there will surely be a note included with this material. I offer i.e. Services...

Mark: Indeed, tell us. Perhaps let's switch the language - Let's switch to English, OK? You can present what you can say in English, OK? Let's talk about your translations - what you can do in English.

Michael: Well, I offer translations. Since I use and learn and practice English language for over 20 years...

Mark: Have you ever been to USA?

Michael: Yes, I've been in and out of the USA since I was about 8 years old. I lived there between 1996 and 2003, continuously for 7 years. I've finished my high school in the United States, I've studied a little bit...

Mark: You are well educated in English.

Michael: ...but since my father died in 1999, since '98 I was on my own and I worked in information technology, as a software developer, as many different roles.

Mark: Let's switch back to Polish. Many people do not understand what you're talking about. Tell us next about your IT education.

Michael: My education - in quotes, because I was learning by doing, by experience, because I could not afford to pay for college, whereas since '98 I've been working in IT, I participated in over 30 projects, most of them were successfully completed. For seven years, I lived and worked in the United States, where I finished high school, then from year '98 I've been working in IT. In 2003, I went back to Poland, so I've been in Poland for over 10 years. So, what I can offer is i.e. English tutoring, translations from/to English language, proofreading.

Mark: You speak of IT translations?

Michael: Well, of course, specialized translations, by all means - specialized and general translations. And also, of course, anything that has to do with information technology, that is, web site development, software...

Mark: Online store?

Michael: ... online stores, CMSes, database applications, consulting - IT consulting, Internet marketing - virtually anything related to computers or the Internet. Thanks to my over 10 years of IT experience, I worked in most industries - more than 30 projects were carried out, as I have already mentioned. But, for the last 6 years, I'm also dealing with other topics - in addition to English language, in addition to IT, I'm also working with energy medicine / so called alternative (medicine) as well as wellness.

Mark: Have you finished any courses as well?

Michael: I've finished i.e. a herbal remedies course, with diploma obviously. For over 6 years I've been a practitioner in energy medicine. I own specialized devices - one such device costs more than 12 thousand zloty (PLN). Naturally, I could sell them, if only people had a little more awareness about energy medicine. I have 3 such devices - two are held in lien, because of financial problems I had to pawn them. One I left for myself because, well, without these devices I do not know in fact whether I would still be living at all. Because, what took place allows me to do clearing on a regular basis.

Mark: Zapper, i.e.?

Michael: Zapper, of course, but also energy medicine. Thus, in spite of repeated intrusions into my body, I'm still alive. There will also be included a link to the site (www.vibrationalhealing.pl) which I have for the last several months. All of the information will be there, so if anyone is interested in services in this area, I'm thankful for all the help.

Mark: I urge all owners of herbal shops - if you would like to help Michael, simply offer him a job order. There won't be any big fees for this, right?

Michael: At vibrationalhealing.pl obviously I also have information that there is a minimum amount, but there's no maximum amount. If someone wants to show appreciation for my work for the last 6 years, when I was working mostly for free and paid out of my pocket - these are tens of thousands or hundreds of thousands of dollars that have been invested in what I did - I do not speak only about the anti-vaccine campaign. And, of course, what also occurred as repercussions, by those who believe that they have the right to decide what you can and cannot talk about. So, if someone can find gratitude in this way, I do not have anything against (that) obviously. On the other hand, I do not sit on the street or at a booth with beer and ask for money. All the time I am doing what I can, so if anyone can show their gratitude, I will also be grateful.

Mark: Ladies and gentlemen, there are so many books to be translated into Polish and Polish into English. If someone wants to e.g. publish their book in English, we can assist

them. Michael is perfect when it comes to translation. Well, and we need such people. It is simply unbelievable that someone like Michael at the moment this simply looks like begging.

Michael: Well, maybe not begging, but this is also, of course, a way for me to protect myself. On the other hand, I have no choice but to start talking about these matters. I expect that at last I will be able to afford to resolve sort these matters out properly. Because, these are repeated violations of human rights. It is systematic humiliations, blocking (me)...

Mark: Perhaps I should mention that also, i.e. thanks to you, this level of public awareness shot up exorbitantly since year 2009. At the moment, I can see on my blog how many people understand important issues and before, when we were starting - they were disbelieving.

Michael: I certainly have some contribution in this, of course. Because, as I say, despite the fact that the 'swine case' - this site was suspended in year 2010 - but I work all the time on many other fronts. Perhaps I will not go into some of the topics, because...

Mark: Perhaps in (our) next conversations?

Michael: Perhaps in the next talks. However, as I say - thank you Mark that we could meet and maybe during our next talks we'll have the opportunity to talk about these topics. Because, as we already mentioned - it's not only the vaccinations. There are a lot of these topics. And it really comes down to large-scale depopulation.

Mark: Ladies and gentlemen, this is about our lives. About the lives of us all - your children, your grandchildren. If at all we'll live up to that time, when there are grandchildren. No, I think we will win after all, Michael, and I think that the possibility of publishing these kinds of talks on the Internet, even using a service that is in possession of these people - 'YouTube' - also proves that we are strong.

Michael: First and foremost, it's necessary to speak up - not to be afraid to speak up. And, of course, to arrive - through experience and one's own work - at what is the truth, because in our times, it is very difficult to capture what is real and what is virtual. So, the most important thing is not get intimidated. In spite of all that is taking place, there are certain values that should be sustained. So, no one will shut my mouth, despite all that took place. And thanks to Mark, I hope, we will reach a larger group of people and, as I say, it's enough if you give me a job order. I did translations, I'm doing (these) all the time. Only there are simply so few of them that I'm unable to survive from these. However, by all means, books, exactly, or any sort of publications...

Mark: Bilateral?

Michael: ... Bilateral. From English language to Polish language, from Polish language to English language. These are things that I can do without a problem. I can also do light physical work, of course. On the other hand, I cannot unfortunately, due to my health, go for construction or some such thing normally yet.

Mark: No, that's not the point. Dear Ladies and Gentlemen - contact with Michael will be given in the link below, so it will shown during the course of this interview, when assembled. However, I'm already inviting you for another conversation with Michael, this time it will about...

Michael: A little lighter topic.

Mark: ... a little lighter topic. We'll be talking about these things that plague us, precisely. You are an excellent specialist. I can see Michael's knowledge. You've deepened your

knowledge in the last 4 years.

Michael: I'm constantly expanding on my knowledge. And the so called 'rabbit hole' is so deep that the deeper you enter, the more you realize that you know nothing. You have to remember that the people who are laughing, saying that it is a conspiracy of some sort, or that these are conspiracy theories, have no idea what they are talking about...

Mark: Or, they are agents.

Michael: Either they're agents or have no idea what they're talking about. It is said that 'ignorance is bliss'. These publications are normally available to all - it's enough to spend 15 minutes daily to get informed. Or, simply, to learn humility and to not say anything, instead of talking nonsense. So, that is my advice. Thank you very much.
